She came from Quang Tri to Saigon on 14.05.14, and left Saigon for Dong Nai at around 8:15am on 15.05.14. This is the first time all these three came to Dong Nai; they are not familiar with roads, things, or had any connection with the workers here to "rouse" or "incite" them.

Thus, through this letter, I respectfully suggest that Public Security Minister Tran Dai Quang Order the Dong Nai Public Security Department to free immediately and unconditionally Le Thi Phuong Anh and her two friends.
