GENEVA - In advance of the Socialist Republic of Vietnam's Universal Periodic Review, a coalition of Vietnamese and international human rights organizations will host a side event on February 4, 2014 at the Palais Des Nations to shine a spotlight on the most egregious human rights abuses in Vietnam today.

The event, titled "With Membership Comes Responsibility: Ensuring Human Rights in Vietnam," will bring together human rights experts and activists. Among the speakers are human rights defenders from Vietnam including: a human rights lawyer, the mother of an imprisoned activist, and a citizen journalist. They will speak on the challenges facing civil society and the growing crackdown in Vietnam.
